The National Complete Streets Coalition, a program of Smart Growth America, seeks to fundamentally transform the look, feel and function of our communities' streets by changing the way they are planned, designed and constructed to better support the needs of all users. Our Coalition represents the broad interests of users of the transportation system and transportation professionals. Together, we work for the adoption and implementation of Complete Streets policies. 
